In recent years, availability of grant funds has diminished and the proceeds from the Bench & Bar Golf Tournament have become even more critical to the success and the continuation of the program. Your financial support of this project will help make it possible to coordinate the volunteer efforts of over 1,000 attorneys in Polk County. In 2019, volunteers provided assistance to over 800 new clients. At a conservative hourly rate of \$200, attorneys contributed close to \$500,000 in legal assistance to indigent residents of Polk County. Your support of this program will allow this project to continue to work toward the goal of ensuring equal access to the legal system for all of those in need.
